CFC Committee (Steve S, Chair) The Area 53 Correctional Facility Committee held its Quarterly meeting on June 9 at the RAC Building. 16 GIRs and 12 Outside Sponsors of institutional meetings gave a report on their group's activities. Jeanne Smythe attended and gave a short report on the Conference, focusing on the activities that related to corrections service work. We had a successful Workshop in April, with 112 interested or involved A.A.'s attending to hear panels of Outside Sponsors, GIRs, and men and women who found A.A. behind the walls and have remained sober and active after getting out. Terry Collins, Director of the Ohio Department of Rehabilitation and Corrections and a great Friend of AA kicked off the conference with a talk about the difference our work makes in the lives of incarcerated A.A.s as well as our society as a whole. The workshop is self-supporting with funds coming from passing the basket and contributions from several A.A. groups. Thanks to these contributions we were able to offer lunch as part of the workshop experience without requesting a fee to attend the workshop. We are talking with a local church about renting storage space for our literature program. We are currently storing our literature at central office, but the space is inadequate. I am hopeful that we can work out the arrangements with the church this month. If this works out, we will move the location of our steering committee and quarterly meetings to the church as well. The committee approved a budget of up to \$50 per month for literature storage to be paid out of the jug money in keeping with our commitment to keep the literature program self-supporting. So far this year, we have purchased \$7,784 of A.A. literature for distribution by outside sponsors to incarcerated A.A.s. The committee authorized another \$5,000 in purchases for the coming quarter. This is a point worth noting: all of the literature is distributed one A.A. to another. We do not donate this literature directly to the institutions. These purchases (and the cost of storing the literature) come directly from the jug money donations of A.A.s in Area 53. The area's budget for our committee is not used to cover any of the costs of the literature program. Our correspondence and temporary contact programs continued to provide an outside contact for incarcerated A.A.s and help for those making the transition to A.A. on the outside. We had nearly 30 requests from those inside last month. If anyone would like to find out more about these programs, see me and I will get you signed up. Our non-literature costs for the year stand at \$251 dollars. I have provided our financial report to the Area Treasurer and have requested \$129 from our area budget to pay our second quarter costs. Tom Bowman was elected to fill the vacant position of Alternate Liaison to the DRC. We will be setting up and staffing our display at the State Convention in July and we hope that we can offer more of our programs and support to the other area's in Ohio. We also want to develop a GIR school, modeled on the area's successful GSR school concept. If anyone would like a copy of the financial report or this report, see me and I will arrange to send you one. CPC/PI Committee CPC/PI Committee (Suzan T, Chair) In the 2nd quarter of 2009, the CPC/PI Committee held our first workshop for those new to this service with 15 in attendance. The new Area 53 Website was developed and is available at today's assembly in the back for viewing questions/comments/feedback are appreciated and can be emailed directly to the Webmaster or we encourage attendance at our regular monthly meeting, which is held the 2nd Sat of the month at 11 a.m. at Panera Bread on N. High St. The slide presentation from the workshop is available for viewing on the Website and the committee will post meeting minutes beginning this month so that districts outside of Columbus can stay informed if unable to attend. We are asking that all DCMs review their district page an submit updated information if necessary. Other current issues before the committee include continued outreach to Home Groups to encourage participation, educating speakers to give presentations at non-AA meetings, and developing an orientation for communicating what AA does and does not do for those who may be attending meetings as directed by the courts or other outside facilities. The committee continues to grow and is grateful for the opportunity to serve.

**Treatment Facility Committee** (Virginia P, chair) Several people have expressed interest in ser ing on this committee. No meeting has been held--E-mail difficulties have not helped. No TF Kit received from NY GSO, but I do have previous chair's information. A co-chair has been found to help with this big job.

COGF Liaison Report (Dennis B. COGF Advisory Board Chair) COGF is located at 1561 Old Leonard Ave and is the Intergroup for a large part of the Area 53 service area. COGF has quarterly members meetings the Saturday before the Area Assembly in March, June, September and December. All groups that are members of COGF are encouraged to elect an Intergroup Representative to participate in the Members Meetings. The COGF Intergroup Representatives also meet as a committee on the second Saturday of each month when there is not a Members Meeting. GSO announced a fairly significant price increase on AA literature effective June 1, 2009. COGF has taken money out of our prudent reserve to buy a large quantity of Big Books prior to June 1 and will make these Big Books available for sale at the current price through September 1, if supplies last, to help cushion the impact of these increase on the groups. We are continuing to explore alternatives to our current location and have entered into negotiations with an office in a building on 100 W. Third St. The building has two adjoining suites available. Each suite individually would be too small, but the two suites together are outside our price range so we are seeing if the building manager will split one of the suites. If we can reach an acceptable financial arrangement, the COGF Advisory Board will vote on the move at its August 1, 2009 meeting.

**Delegate** (Jean S., Delegate Panel 59 Area 53): <u>REPORT ON THE 59<sup>TH</sup> GENERAL SERVICE</u> <u>CONFERENCE</u> **April 25- May 2, 2009** Our theme this year was "Our Commitment to Carry A.A.'s message - Enthusiasm and Gratitude in Action". As Delegates in this week-long event, we were given constant opportunities to carry our enthusiasm for Alcoholics Anonymous, through the dedication to the process of fulfilling our Founders's belief in the democracy of world service, and departed with the gratitude that all had come together to bring the collective consciences of 1000's of groups to guide our Conference decisions. Our labors were joyous, sometimes frustrating and physically exhausting, but always filled with the awe at the process we witnessed.

Arriving a few days early I was touring the General Service Office when I was honored to be asked to speak at the Friday Noon Meeting held there. It was a wonderful opportunity to look at my past and share the journey that had led to that moment of "giving- back" a small piece of my sobriety. As I looked out at the Trustees, General Office staff, and other A.A. members in the audience, I realized strongly why we were all there - to carry A.A.'s message and continue our own growth in sobriety.

Hours before the beginning of the Conference I had an accident and was dubbed "the most colorful" delegate because of all my bruises and cast. I was easy to spot in the crowd! Although my injuries made my duties a little more difficult, the kindness and concern shown me were amazing and led to many enlightening conversations with everyone attending.

Saturday evening began with a Delegates' Only Meeting to help prepare us for the week. On Sunday morning the Remote Communities Seminar gave us opportunities to learn how other Areas overcome problems of language, culture, or geographic distance and to share experiences and problems.

The official start of the 59<sup>th</sup> General Service Conference began at 1:15 Sunday with the roll call of all Conference members - delegates, directors, trustees, and voting staff. That afternoon each committee met with their corresponding Trustee Committee to discuss and ask questions about the upcoming agenda

items to be decided that week. Sunday evening was the opening dinner followed by 6 speakers, including Ken B., Trustee, Joanne N. And Robert H., Delegates, Rick W., G.S.O. Staff, and Robert L, AAWS Director.

Over the next days, meetings by our Committee assignments, Regional meetings, workshops, and presentations, sharing and voting sessions engaged us from 8 or 9 in the morning until 11 or 12 each evening. All 132 participants focused on the work at hand, turning to our Higher Power for strength and guidance when our own resources were depleted.

My assignment on the Public Information Committee was especially intense with a long agenda. Some of the results were approval of an up-dated version of "A Message to Teenagers", a new wall poster for young people, a truly inspiring new video from submissions from four young people, and the draft of the 2010 Membership Survey.

We participated in the election of a new East Central Regional Trustee, Pamela R of Michigan, replacing Bob M., the new Southeast Regional Trustee will be Eleanor N., of South Carolina, replacing Howard L., and the new Trustee-At- Large/U.S. will be Don M of Louisiana, filling the spot previously held by Dorothy W. The new general service trustees are George M. of Michigan, who will be a director in the A.A.W.S. Board, and Don M. of Colorado on the Grapevine Board.

Once again the Conference set a new record for the longest-lasting, since we didn't finish voting on the floor actions until after 2 AM. on Saturday morning. After a few hours sleep, the farewells to the rotating Trustees and Chairman of the Board followed. It was a bittersweet goodbye for many. They each spoke of the joys, disappointments, and gratitude of their journeys through service to our Fellowship. I was struck again by how much we had gained from these trusted servants who give so much to continuing A.A.'s legacy around the world.

<u>AAWS INFORMATION</u> Leonard B., chair, welcomed Phyllis H., the new general manager of the GSO. They co-chaired sessions throughout the Conference. The 2010 General Service Conference will be held in Rye, NY. to try to reduce costs. The theme will be: "Practicing A.A.'s Principles - the Pathway to Unity". Enthusiasm rises for our upcoming 2010 International Convention to be held in San Antonio, Texas on July 1-4, 2010. Rick W. chairs this committee that is planning the event for thousands of A.A.'s

who will gather to celebrate our 75<sup>th</sup> Anniversary. Registration and information will be at www.aa.org. in August 2009 and by mailings. FINANCIAL The 2009 General Service Office Budget was crafted with the goal that the Reserve Fund would be at a 9month range in three years. The Budget includes price increases for most books and pamphlets, while keeping shipping and handling charges at current levels. G.S.O. has initiated wide-ranging cost and saving measures. Group contributions for the year were 3.2% less than budgeted. Here in Area 53, only 26.7% of our registered groups contributed at all, compared to over 46% nationally. If all of our groups contributed but \$6.49 per member each year, A.A. would be selfsupporting, LITERATURE In 2008 AAWS distributed 6.6 million pieces of literature in English, over ½ million pieces in Spanish, and about 130,000 pieces in French. Big Book sales in all formats was 1.1 million. New translations of literature have been accomplished in Kyrgyz, Vietnamese, Croatian, and Macedonian. The Big Book and The Twelve and Twelve will be available this year to Kindle Reader customers. They may also be read on the web site. AAGV Since 1996 the Grapevine has only raised its price twice. To catch up with inflation, the cost will go to \$27.00 per year (still only \$2.25 per monthly copy) on July 1, 2009. Updating the look of our "meeting in print" was a major step toward two goals of being color-ful and staple-free to be a more effective 12 Step tool. They are encouraging your comments and ideas before evaluating the changes. <u>OTHER THOUGHTS AND REFLECTIONS</u> A copy of the complete Conference Advisory Actions and Additional Considerations is attached so that you can see the results of the items discussed at our Mini-Conference and some that were not covered.

The complete version of the Conference, containing speakers, workshops, and presentations, should be available at our September Assembly. This is truly worth reading and sharing with your groups. As my experience at the 59<sup>th</sup> General Service Conference came to an end, I feel compelled to thank Area 53 for the opportunity to participate in this endeavor. Our East Central Region does such a superb job in educating and preparing us through our service structure, Delegates Past and Present Conference, Assemblies, and Mini-Conferences. I attended this event with a firm consensus of our Area's voice, and the freedom to listen and respond to new information that was presented. I have come to realize the

value of every member's comments and ideas, and the wisdom of adhering to our program's principles, Traditions, and Concepts as we move to the future in Alcoholics Anonymous.

I have also attended District 10's Networking meeting, the April CPC/PI Committee meeting, the CFC Workshop, Area 56's Mini Conference and Area 53 Inventory. I am currently working on Unity Breakfast and Unity Day planning. Thank you for the opportunity to serve you.
