- The committee continues to take an information session into Netcare. We will need additional volunteers for the upcoming holidays.
- We continue to have a literature and information display at the Adult Parole Authority of the O.D.R.C. and hope to facilitate an information session for parole officers in 2013.
- We continue to place business cards with COGF contact information in places where alcoholics might go before they find A.A.
- We have A.A. business cards in the lobbies of most Franklin County libraries and in Athens, Portsmouth and Marietta. Need volunteers to place cards in libraries across Area.
- We intend to contact central Ohio centers in the international community to place business cards in their various community centers.
- At our committee meeting, when time allows, we review literature relevant to CPC/PI to familiarize committee members with the traditions that govern our committee's purposes.
- Our committee continues to cooperate with the COGF PI Committee.
- With COGF PI, we are looking for volunteers in the Chillicothe area to speak about what A.A. does and does not do to an Ohio U. chemical dependency class once a quarter.
- In August with the COGF PI Committee, we staffed a very successful booth at the Addiction Studies Institute.

- We have an updated display we use to help us look professional at conferences, health fairs, member and other information sessions. It was brought to the Assembly.
- We have placed literature at Ohio Wesleyan University and Ohio State University and seek volunteers to help with these placements or possible information sessions.
- We have received the go ahead from Columbus Public Schools to place big books in their libraries. We will need additional funds for this project. We also expect approval to place age-appropriate literature in their guidance offices and will seek additional funding for this as well. We are also contacting the ESL programs to see if there is any service we can provide for those communities. We are also contacting schools to see if they are interested in A.A. speakers.

Good morning trusted servants.

Area 53 lost a dedicated and principled Delegate in Glen P. who died August 1.

I give this report, thankful to be of service as your Delegate and in keeping with the Area 53 Guidelines.

Glen's final days were difficult and painful yet every time I saw Glen a sense of duty to Alcoholics Anonymous and faith in God always showed through no matter how he suffered.

On July 23, nine days before his passing, Glen approved the final draft of his General Service Conference report which I am prepared to read today - just as Glen had asked me to.

Glen's Conference report was his final act of service to the fellowship. That accomplishment was, in my opinion, an awesome demonstration of his dedication and sense of duty.

I saw Glen in the toughest times imaginable and always Glen was genial and self-effacing. Glen just considered himself a trusted servant humbled by the honor of being your Delegate.

The 2013 Area 53 Mini-Conference will be held March 8 – 10 at Deer Creek State Park in Mt. Sterling Ohio. The Theme will be "The General Service Conference Takes Its Inventory – Our Solution in Action." Since the June assembly, the Area 53 Mini-Conference Committee held full committee meetings twice, in July and August. The Mini-Conference Committee is a standing committee of Area 53 Central and SE Ohio. Your mini-conference committee meets on the second Thursday of the month approximately 10 months of the year except for two months in the summer. The committee's duties include finding a conference location, banquet planning, hospitality suite, creating the program, hosting guest s from GSO and the General Service Board, flyers and mailings and registration.

If you want an opportunity to serve, you can be a greeter, an agenda topic chair; you can work registration table shifts or hospitality suite shifts or be in floor management.
