OFFICER REPORTS – Greg M, Alternate Chair, presiding:

Delegate – Dave C., Delegate, reported:

In July and August more than 600 randomly selected groups in the US and Canada participated in an in an AA membership survey. Seven Central and SE Ohio groups were included in the survey.

The information collected will be included in the 2014 AA membership pamphlet, P-48, which should be produced next year. This pamphlet informs the general public, media, and professionals about the composition of AA. Information collected includes average age of members, average sobriety time, member occupations, marital status, number of meetings AAs attend, and average size of AA meetings.

Participating groups were: New Life Direction, Zanesville; Sunday Variety, Marietta; SOA, Springfield; Rush Hour Recovery, Reynoldsburg; and, in Columbus, Open Door, Real Recovery Women's, and Roundtable Discussion.

Thanks for the support from COGF, AOIO, District 12, District 7, District 15 and the Area 53 trusted servants - especially the trusted servants in the AA groups.

Thanks to the groups for sending me and seven other Area 53 trusted servants to participate in the East Central Regional / 58th Ohio State Conference in Perrysburg Ohio July 25 – 27. The sharing session I participated on was on area registrars and recording/mailing secretaries. The information shared there will help future registrars more effectively serve the groups, and keep the AA community better informed about carrying the message through group, district, and service committee events and activities. It was apparent that digital communication continues is becoming more wide-spread as a tool for communications. The East Central Region is one of six in the US and includes Ohio, Michigan, Indiana, Illinois and Wisconsin. AA news and information is being profoundly influenced by digital communication and it seems we may be just scratching the surface as regards using the internet and Area web sites.

COGF and Area 53 co-sponsored Unity day on August 17 at Hannah Park in Gahanna Ohio. The COGF and Area 53 Archives were there. Presentations about COGF and Area 53 History and the history of the 1939 original Big Book were inspiring and informative. Area 53 Archivist Tom V. was the AA lead.

The Final Report of the 64th General Service Conference of Alcoholics Anonymous is now available. I will be at Rule 62 Day on Sunday, September 21 at Hannah Park in Gahanna with copies of the 88-page booklet that sums up the actions, sharing, and reports of AA World Service and Grapevine and General Service Board of trustees of Alcoholics Anonymous.

The six-month information on group contributions to 'New York' (General Service Board/GSO) is now available. If your group has a GSR you have already received the record GSO has on your personal group's contribution. Group contributions through June of 2014 are down eight percent from the same time in 2013. If you want to know how your money is spent by GSO/General Service in the world service office in New York, read the Conference report. The yellow booklet is jammed with reports and descriptions of the breadth of services provided by the world service office (GSO).

- Jim F., Alternate Registrar, brought to our attention that the domain name area53aa.org will be coming up for renewal.
- Greg M., Alternate Chair, spoke as an interested A.A. concerning the fact that C.O.G.F. discontinued the 800 number. He's concerned about inmates, people in "no tell motels," people in psych wards, as well as people in rural areas who do not have cell phones or who have limited cell phone service.
- Ed A. asked about the Area Inventory. Greg M. said the Area is trying to clean up the Area 53 mailing list before doing the mailing. Inventory can still be completed on-line. They are still collecting them. The DCMs and GSRs have also not done a door-to-door campaign. It would have been an item of old business today, but it was pushed to December because of the elections.

ASK-IT-BASKET

1. How does a group decide what district to be in if they are on the border?

Bill S., Past Delegate, explained that this is covered in the Area 53 Guidelines for redistricting. What happens if you're an active group in a dark district is not explained. He suggested, if your group is in a dark district, you can join an active district.

Bill Y., Webmaster, explained that, wherever possible, the new boundaries are rivers and highways.

2. Has any consideration been given to changing the Area 53 page in the COGF Conscious Contact to reflect functions going on in the Area?

COGF gives the Area one page in the Conscious Contact. The Committee has chosen to use that page for Area contact information. If the DCMs would like to make a change, it can be brought to the Area Committee. It's up to the GSRs to decide, but any group can put a separate announcement in the Conscious Contact of their events.

3. Does a District or its officers or GSR have the right to penalize or censor an A.A. member if they disagree with their point of view or a particular speaker they get to speak at an A.A. home group?

Stephen S. stated, "The simple answer is, 'No.""

Bill S., Past Delegate, explained:

- Alcoholics Anonymous should never be punitive ever.
- If you have a speaker that says something you don't agree with, shame on you for selecting him or her, not shame on the speaker.

Frank G. stated the need is to give individuals more information rather than any kind of penalty.
