Peggy A. Opens Meeting at 10:15 am Opens with We Version of the Serenity Prayer.

Dana P. – Long Form of the Concepts

Peggy A – Introduced Frank G. – Mini-Conference Chair. Mini-conference is coming up in March, so we are offering a prize for people who register today. Payment for dinner and lunch isn't necessary when registering today. If we only get a few we have a prize, if there are more then we will have a bigger basket. Think about registering Sandra will give more details on payment whether Credit Card or cash. We have plenty of forms.

Peggy A – Roll Call

GSRs 31, Alternate GSRs 1, DCMC 1, DCMs 9, Alternate DCMs 4, Committee Chairs 4, Panel Officers 10, Past Delegate 1, Interested AA 5.

Peggy A - **Review of Agenda**. She advises that Dan H. will have a review of the parliamentary process. Peggy also advises that she has no unfinished business to talk about on the Agenda, so we are moving on to new business. The informational segment will be given by Frank G., Alternate Delegate. Then officer's reports, then lunch. Any questions about the agenda? None were asked.

Barb S. - **September Assembly Minutes** – Barbi advises that the minutes were distributed and online. She asked if there were any additions or corrections. Bill Y advises that under the officers reports the Alternate Chairperson is listed as Dan R. and should be Dan H. Motion to accept as corrected - Julie J., second by Marcia H. No opposed.

Dan S. - Treasurer's Report - Did everyone get a chance to look at the report? This is accurate through Wednesday of last week. The budget shows that we have money coming in. We are little over budget as according to line 4 as far a contributions go. Past Treasurer's have that pretty zeroed in at around \$16,500. Any questions on incoming. Dan then goes over outgoing money. Officers expenses, as we go into next year, you can see significant differences. If you look at Line 17 and 15 show significant differences between what is projected than what is actual. I think as Treasurer I will be able to do a better job at distributing those funds to encourage that activity with Past Delegates. Diving into this job, last year, I think I had the idea, let's make an equal amount available to all Past Delegates and only a couple participated, so I think I could have more freely distributed that money. to encourage the past delegates to participate. So we will do a better job at that next year. Operating Expenses, pretty good there. Meeting and Convention Expenses, We had to bump up the Assembly expenses, relative to what was budgeted. Unity Day did not take place. We did pay out for the State Convention and the International. Committee expenses are as expected. Any questions? There were no questions. Dan goes on to explain. Line 48 shows that we are comfortably above our prudent reserve. Dan reads from AA Guidelines - Where Money and Spirituality Mix. "Members celebrate sobriety by giving time, energy and money in support of our Twelfth Step—carrying the message—the basic service that the A.A. Fellowship offers. Members assure that group expenses are paid by putting money into the basket passed at

each meeting. It is each member's responsibility to support the services that have been requested by the A.A. Fellowship, to help facilitate A.A.'s vital Twelfth Step. Contributions are made in a spirit of sacrifice, and they honor A.A.'s code of "love and service." Contributions also underscore the spiritual nature of our Fellowship and our mutual love and trust. We have found that these contributions are as important to each member as they are to the service centers supported." As GSRs that is something to

take back to your Groups. Remember that. Dan reads from a old song from 1944, this is also for the GSRs to take back to their Groups – The Title is "Dollar Aint a Dollar Anymore." Oh a Dollar won't buy what it used to, Don't buy what it used to, Don't buy what it used to. A Dollar Bill don't buy what it used to. 'Cause a Dollar ain't a Dollar anymore." Thanks for the opportunity. Peggy A. requests a Motion to Approve the Treasurer's Report. Taffy J., Motions. Patrice P., Seconds. No opposed.

Peggy A. introduces Dan H. – Alternate Chairperson – Goes over the **Parliamentary Guide Handout** and The Third Legacy Procedure.

After going over the Handout Stephen Sheldon, GSR for Three Legacies. On the portion on the Motion to Reconsider, if somebody voted on the winning side and says that I would like to change my vote, this is a motion to reconsider, this requires a second, the second can come from anybody. It doesn't have to be on the winning side. Arron B – District 21, Alternate DCM. - What is right of decision vs. What do we take back to home group. Dan H advised that Frank G would handle the question for the DCM.

Peggy A. - Advises that Area 53 had no unfinished business. We are moving on to New Business

Kristi H – Area 53 Delegate – Advises on a proposal to update the Area 53 Guidelines, as discussed on Area Planning Committee Meeting on October 11th. Kristi distributes handout. We would like to create a new officer as Website and Communications Officer. Historically this position has been served by a person who serves on a committee of one, who manages the website and website communications. As we move to the website to communicate with our members, we would like to make this person an officer. As it stands right now, that person doesn't even have a vote at the Assembly. But, we feel that it is important to have that person accountable to the Assembly and the Assembly accountable to that person. If you look at the bottom of the page, there is a preface, about where we are coming from. Ideally, we would like to have this happen so that in our elections in September,, we are able to vote in a Website and Communications Officer so that they can start Panel 67. So what we have is a motion to amend the Guidelines. That's typically how things get done for the Assembly. What we have is a proposal to create a new officer and add that person to the committee. The title and duties of the position will be Website and Communication Officer. Kristy refers to the handout and explains that this is more information than we will put into the Guidelines, this is for you to take back to your Groups, to talk about whether we can add a new officer or not. Kristi explains how the process to update the guidelines works. She reads from of the Area 53 Guidelines under Article XIV. Today we will have some limited discussion and whether we will consider this change and then take it back to the Groups. Ed S. - I would like a paid professional to be considered to update the website. That person would report to the PI committee. Steven S. – Made a point of clarification. We are discussing on whether to vote on this, not the content of the topic. Does this have enough merit in order to take this topic back to the groups. Madeline. - I'm not opposed to it and I am not for it. We are going to limit ourselves to the pool of expertise in this topic if that have to attend all of the meetings. Right now, the web master doesn't have to attend all of that stuff. Right now it's like the archives. It's a position that you can hold as long as you can hold it. It's easier right now to find someone who has the time and ability to do this position. One of the problems we will find is we are going to limit ourselves to people that would be qualified to hold the position. This person would have to go to the planning meeting and assemblies. This is my concern. Reminds me of when we did the newsletter. Dennis B. was in publishing, he was our recording secretary and did a beautiful newsletter, but everyone else after that pulled their hair out. Because we made it so complicated and it cost so much money, 10 years later, we got rid of it. In the mean time we lost a ton of good workers because we couldn't put it in the same format. Kristi calls the question. Motion was made to take the proposal back to the groups. Vote was 46 for the proposal, 6 opposed, no abstentions. Peggy A, then asks for Minority Opinion - Sheryl

S. CPC/PI Chair - The reason I voted against it, is because I don't believe it should be an officer position. I believe it should be looked into and investigated. I don't agree with an officer. I believe that this deserves more input than one or two people. Peggy A. asks if anyone changes their vote as a result of the minority opinion. No change in vote.

Dan S (Treasurer) – **Proposed Budget**. Dan makes sure everyone has the proposed budget in hand. He makes reference to Line 4 and says that it is pretty zeroed in. If you look at our December 13th report, that 7,750 on line item 2 is pretty close. I think we are going to deviate from it a little, but it will be right around there. That gives us our total funds available. Looking at what we spend out, Officer Expenses – you can look at what we have to 2015 and what we anticipate for 2016. Delegate expenses have increased. We simply found that what was budgeted didn't cover what was needed. The same is true with the Chair Person expense on line item 12. That's about the only two deviations in the officer expense category. Operating expenses. Line item 20. The Archive Storage. I see the archivist here. Are we fully moved over to Central Office? Answer - No. Dan continues.. that expense has decreased from \$710 to \$150. This is a significant decrease because the Archives have moved from a rented storage facility to Central Office. We will pay relatively nominal fees. Line 21 has changed – we haven't used that one-thousand dollars. We are going to lower that budgeted line. Post office box has increased a little bit. Web services has changed. What we are doing is protecting the domain name. I believe that will be a decade out. So we will try to protect that long term. Thankfully this projector has been provided to us, but we are going to get our own so we can be self-supporting. So we've budgeted \$500, so we can purchase a wireless projector. Dan S. then asks if there were questions. Paul H. CFC Chair. - I just had a question on Delegate expenses. You have \$3000 budgeted, for next year. This year we spent \$3800 so far and we had a budget of \$4000 because we upped it. Why is it going down? Dan defers the questions to Kristi H. - I will not have a Regional Forum to go to next year and that is in Wisconsin. It was about an \$800 trip. Dan S. continues. ...and those funds as you recall, were from the International that we transferred over. Meeting convention expenses has changed. Blue Moon goes for 300 dollars an event and we didn't have the proper amount of money budgeted in 2015. We don't have the Mini-conference housing subsidy which was the excess funds from the State Convention, that was line item 31. It was a joint decision between COGF and Area not to have Unity Day in 2016. Committee Expenses have fluctuated. Some of the committees now have Chairs and their expenses have increased, such as Treatment. Special Needs now has a Chairperson and they are active. We have increased their budgets. The entire Finance Committee, the Treasurer, Alternate Treasurer, the Chairperson and Alternate Chairperson have review this and opportunity for input into that. Does anybody have any questions on the proposals? Hearing no questions. Requests a motion to accept the proposed budget for 2016. Teri G. makes motion to accept, Kalen C. seconds. Peggy A placed the Proposed Budget to a vote. 51 for the Proposed Budget – no opposed. Passed.

Frank G., Mini-Conference Chair provides the **Informational Segment on Roberts Rules of Orders**. – Frank advises on how to Robert's Rules of Order is used at the Assembly. Peggy A., then asks if there were any questions for Frank. Taffy J, DCM, District 28. – Do we always have to take a decision to the group before we vote? Frank G. - It really depends on the Chair and the Assembly at that Assembly. There is no set rule on that. I know that some people were crying foul because it wasn't done. But remember we were Trusted Servants to vote. If somebody says, I don't have enough information and I want to Table the Motion so I can take is to my Group, then that process goes. If no one says that, then we vote. Frank invites Madeline to share. I've been in service since 1991 and a lot of times and we didn't know at these Assemblies the same thing that we are talking about right now. And there would be Glenn W. sitting in the very back, Rick B. and all of them and they would be hollering, they wouldn't go to the Mic. They would holler, "Take it to the Groups!!" That was embedded into our heads. Now we have a Standing Committee, which is the Area Committee and the

afternoon when the DCMs meet in the morning and the Area Committee meets in the afternoon, They can make a lot of decisions. They have a lot of free reign to make a lot of decisions, because they have the Right of Decision. But they don't have the right to abuse that Right of Decision. That is were we have to be very careful. There is a fine line on that. It's not only at this level, it's at our Home Group level. It's at our Regional level and it's in New York. There's a fine line. That's when you go to New York, you have people debating that fine line. This will always go on. We will be having these discussions. We don't need to be so rigid. Just have the discussion and go on. There may not be a clear answer for every single thing. We do the best we can and then move on. Whether we agree with it or not. We don't need to rehash it and re-brining it up. We just do it and move on. Frank G continues. I kinda went that direction with my report. There is a lot of responsibility with being a GSR or DCM. There is a lot of study and time to be a responsible elected Trusted Servant. It's our responsibility not to cry foul. To learn, so that next time I can say that I don't have enough information. Just Table the Motion. So, it's my responsibility to know. Gregg G, District 22 GSR. - As you mentioned, Robert's Rules of Order is complicated. I wonder if in the future, before the beginning of the meeting if we could have a general reminder of the some of the procedures. We only meet quarterly and they are complicated. Peggy A – To answer the question. In the future Assemblies that I am Chairing, we are going to have the Parliamentary Procedures on the back of the page every time and we will review them every time for the new GSRs or anyone that is new that is coming. Joe S., District 15 - I have a question on Tabling. If you get the motion and somebody seconds it, doesn't come up to vote then? Do you have to have a 2/3 majority to table an item. - Question was answered as simple majority.

Peggy A. - For lunch it was suggested that we take on hour and half for lunch We'll have an informal vote. An hour for lunch. What time would we want to go to lunch? Ed R advises that we should break after officers reports.

Dan H, Alternate Chairperson – Officer Reports

Dan H. introduces Kristi H. for her **Delegate's Report**. Kristi advises that she picked a couple of topics of interest. The Grapevine Quote of the Day - You can go to Grapevine dot org and sign up. It comes through the email, but you can get it on the phone as well. I thought that this quote from December 9 was very good. She reads a description regarding how AA needed a standard literature, which became the Big Book. Since the last Assembly, I gave a Delegate's Report at Rule 62 Day. She the reads an appreciation note that is published on the Area 53 website. Kristi said that at the last Assembly she wanted to attend the Archives Workshop, but didn't attend. She was completely exhausted and couldn't manage to attend another four day workshop. She attended the Mini-Conference Committee meeting, The District 16 Primary Purpose Workshop, the Area Committee Meeting, the Poindexter Group, another Mini-Conference Meeting. For November, Kristi attended the Mideast Regional Forum in Milwaukee and there were approximately 400 in attendance there and half of them were first timers. She met with the new General Service Manager, Greg Tobin. Several GSO Staff members were at the Forum along with trustees. She also got to meet several incoming Delegates. In the United States there are 93 Delegates and half get elected each year. At the Regional Forum I attended a workshop on contributions to the General Service Office, "Why Should Groups Give." Kristi invited Kalen C to the Mic to advise on his experience to the Region Forum. It was a new experience for him. Kalen said it was great how they brought the New York structure to the Regions. I thought that the International Focus was inspirational. I thought that there were good workshops. I was mostly touched by the Class A Trustees. These are non-alcoholics that do a lot of work for AA and it ties into the work for the CPC/PI committee. I was already excited about nonprofits, so the structure they gave on finances with connection to Spirituality and Self-Support was

really good too. Frank G. shares that it was a learning experience. One of the things I learned, is that I don't know as much as I thought that I knew. Kristi continues with advising that on December 5, she attended the West Side Beginner's Group Anniversary and then the most recent Mini-Conference committee meeting. Upcoming events include the attending a committee meeting regarding the planning the 2017 Ohio State Convention. Area 53 is hosting. We are in the very early stages of planning. There is plenty of work to do. Believe it or next it's practically next year. General Service Conference Report from 2015 is available. Lots of information including the sharing sessions. She also has the Compendium for the Area Inventory that was conducted at the General Service Office for the last three years. It was a highly organized inventory. She also had a preliminary report for the East Regional Forum that was just attended and the most recent Box 459. AA General Service Conference Reports include Spanish copies. If you know of Spanish speaking groups, please advise the Delegate. On July 9. Kristi receives a letter from the Board Treasurer from the General Service Board, that Area 53 contributions for the three months ending March 31, were 10.78% for 2015 and 11.01% for 2014. This puts us at the lowest Area in the United States and Canada in terms of contributions to GSO. Kristi said that it is a matter that needs to be addressed. Why is only one out of every ten groups is contributing to GSO? Why are groups not giving to GSO. We are at the bottom of the barrel. We have a year to work on it. Kristi would like to get people together to talk about what we can do to improve that number. When I give my birthday contribution to GSO. I attach my group number or another group that doesn't give for whatever reason. I think it's my responsibility to ask the groups I attend whether they give to GSO or not. The 7th tradition is to reach the still suffering alcoholic, not just to buy coffee and donuts. Kristi will tell Treasurers how to contribute. She said, I do everything online now, I just go to GSO.org or Area53.org to contribute. I would like to ask a few people to talk about why we don't contribute. Julie - GSR Stop and Safe Group, District 28. I know our group is very small. We have a limited number of home group members and the majority of people who attend are coming from a treatment facility. Even though we are interested in contributing, it has been hard for us and I know many of the groups are just struggling to make their rent. I am not saying it's right, but it's just difficult. Many of these may be smaller groups or they may not have the people or knowledge base to make contributions. Kristi said that data indicates that the groups are getting smaller. Terry GSR for the Good Morning Breakfast Group. - I want to give an opinion from a large group. I represent a lot of long term sobriety at my Home Group. I am also trying to represent change. I have brought up this topic at the group conscious. We made a vote that we are contributing 50 percent to the COGF, 30 percent to Area, 10 percent to GSO and 10 percent to District 34. Trust me, we have discussions on how much we spend on donuts. We talk about picnic and anniversary. I am trying to make a change. I want to focus on a bigger picture for service. Dan S – Treasurer. - I would encourage to take back to the groups Were Money and Spirituality Mix. To talk about sacrifice. We need to ask ourselves, do we value the ability to carry the message to the alcoholic that still suffers. I think the GSRs have the responsibility to explain the structure of Alcoholics Anonymous. I can't tell you how many groups call in and ask why their Group isn't on the back of that Treasurer's Report. I ask who they make the check out to and they reply to Area 53 CFC. We need to explain how Alcoholic's Anonymous is organized. That way we can make out checks properly. Sandy, DCM form District 6, way out east and it's pretty rural out there. The old-timers had a way of doing things and they haven't passed it along to newcomers. The newcomers don't know were to send the money. There is a percentage breakdown. There is a group out my way, that has a Anniversary budget of 800 dollars annually. That just like baffles me. As DCM, my goal is to attend all the meetings in my District. To take with me preprinted envelopes from the District, the Area and GSO. And say, I brought these just in case you need them. I have a lot of old-timers that don't want to be involved in the politics of AA. I think it's important to communicate. Back in St. Louis we didn't have that problem out there. They would have a potluck. The group didn't put anything into it. Everybody brought something. Al, DCM Area 33 and we are dark- When I first came here they would talk about these new meetings. You guys are starting these

new meetings with no service structure. Mel would go around and look for these guys and he would have some foresight. He said that every time you guys would get a resentment, you would start a new meeting, but wouldn't have any structure in place. A lot of these meetings have the same people running the meetings and the same people are putting on the Anniversaries. I have a new saying for them, I call them, Anniversary Anonymous Meetings and that is what they are doing with the money. You can give them all kinds of pamphlets, draw them diagrams and do whatever you want to and look back and they will still say we need this this and this. So I took it upon myself to put a workshop on December 26. I am trying to get some of these guys to come back in. It's going to be at Central Office. We can explain the service structure to them, because they just don't know. Madeline – Last week at group conscious I brought this up. The average person is still giving a dollar in the basket. We have to talk about this and become self supporting. It's not that we are asking folks to give more that what they can afford, we need to give enough to set up a meeting. Everything is going up in price except our donations. I not saying every group should do this, I am saying if you have it give it. Kaylin – Echo what individuals should give in reference to attaching a group number to a donation. Kristi interjects that we get counted in that even if a Group give a dollar a year, they get counted. Ryan C., District 17, Pleasant Valley Group. - Our Group Conscious said that we could give at least a dollar, so we give a dollar a month. Each group could give at least one dollar a month. Every workshop we have, someone speaks on the Seventh Tradition. It may not be on the flier, but if you attend it, you always hear about that at some point during the day. It comes personally with sponsorship and I pass that on. Steve Deters – I picked up some things a long time ago. Some things I saw on paper. Basically referred to the price of things in the 60s as compared to today. The price of cigarettes, a can of coke and gasoline. I picked up a bunch of those pamphlets in Dayton, when I see friends and then leave them at groups. I had a bad habit until a couple of years ago. I was still putting a dollar in the basket. Kristi H – I am going to nominate a couple of people to meet with me to brainstorm how to increase donations. I like Ryan's idea about a dollar a month. Kristi then goes on to discuss the rest of the report from the General Service Office. Sales of book and tapes are down. AAWS sales are down 14% below of what they estimated. That is a considerable negative variance. I don't think that it's anyone's fault. People are just not buying literature. We are going to have to find a different way of funding the fellowship.

Kristi goes over the highlights of the 2015 Trustee's Committee. We have 10 or 11 Trustee's Committees. Here are a couple that I thought that you would be interested in. For the Trustee's Committee on CPC, they agreed to forward to the 2016 Conference which will be in April, the recommendation that the pamphlet, "Three Talks to Medical Societies" by Bill W be retired. They feel it's too lengthy and too dated. The Treatment / Special Needs Committee is going to be forwarding to the Conference, that we drop the word "Special Needs" they removed that from our Committee name, scope and procedures. We are just going to be "Treatment, Accessibilities". We are going to drop Special Needs because we feel the committee needs to be broader in scope. We all are going to have Accessibility issues. We may not be able to hear well or walk up a giant flight of stairs or I can't find parking. So the name change is being forwarded to the General Service Conference. We will likely be taking up these issues at the mini-conference.

Corrections Committee – Change it sure beats sitting in a cell video. Corrections Facility – The Trustee's Committee reviewed the draft video. They are going to replace, "It Sure Beats Sitting in a Cell" They are going to update that one. They will be reviewing the revised draft in January. They are currently exploring the feasibility of doing a North American Corrections Workshop. They sent a simple survey. They asked if we wanted to host a North American Corrections Workshop. Kristy then says that it would be quite an undertaking and would involve a lot of people. We will likely let somebody else do it first and see how it goes. Public Information – The Trustees Committee reviewed a request from our conference to produce a video in regards to AA Members responsibility to Anonymity Online, and they tabled that discussion. In April we will be choosing a date for the 2019

East Central Regional Forum which Frank and Kalen spoke about. Kristi said that she had a list of host contact duties, if anyone is interested in hosting that. It is a good size conference. It is likely bigger than our state convention. We will be talking about this at the conference in February. Four years ago, we had the East Regional Forum in Miamisburg, Ohio.

Regarding the Guideline Change – Kristi wanted to make a point of clarification. She advised that this is not for a web master. Please read the job description. This is for a much broader title than web master. We feel that we need more that just a web master at this stage of the game. Our current web master will be rotating out after this panel. We do know that our web master will be leaving and as a Committee we need to do something. This cannot be exploratory. We can't wing-it. So this puts a lot more structure to it.

Dan H. welcomes everyone back from lunch and said that Frank G. has a small request. Frank G. – Mini-Conference Chair – Last convention I went to, which was part of my requirement. Requesting \$70 to recoup some of my expenses. Dan S, Treasurer advises that Area 53 is operating well above prudent reserve and I put a motion on the floor to approve Frank's request. Paul H. seconds the motion. Dave C., Past Delegate asks what convention was this? Frank answers that this was the last Regional Convention in Milwaukee. There was no opposition.

Dan H. introduces Peggy A., Area 53 Chair Report. Peggy - I want to thank you all for coming out and for all of the support. We made it almost a year with me as a chairperson. I have attended the District 22 Workshop. I may have reported that at the last Assembly. It was a comedy workshop and it was really great. Also, District 10 had a great workshop on the Fourth Step and it was well attended. I attended the District 16 Workshop in Athens. I didn't go to the Forum because of personal issues. Thanks for the privilege of having the chance to go. The next Committee Meeting is on January 10 at COGF at 10:00 am. The people that attend that meeting are the Area Panel, DCMs and their alternates. The morning is when the DCMs meet with their DCMC and the officer's have a small meeting. Some people come for the morning and leave in the afternoon. The afternoon is when the whole committee gets together. The afternoon is where we vote for everything. This is were we decide what it going to be on the Area 53 Agenda. Its were all of the business takes place. This is when miscommunication comes up. When people leave early. It's important to stay for the entire thing. If you can't you cant', I understand. But it's important to be there. There is a meeting at COGF from 9 until 10 and we start right after 10am. Greg gets there early to get out coffee. We are not usually able to start right at 10 so if your there at 10 to 10:30, that's fine. As far as being a DCM, it's important to be there when the voting takes place. To know what to take back to the group and that is where we set the Agenda. At the mini-conference in March, we will be doing full GSR reports this year. I appreciate all you GSRs being here. We didn't do that last year, but we will be doing it this year. We will also do DCM reports. It was requested that we have a DCM School. There is one scheduled on January 16 at Brandy's house at 12:00 pm. I am sure anyone from District 34 would be willing to help you or Paul possibly. I really appreciate being the Chairperson and your patience this first year.

Dan H. introduces Ed A – **Registrar** – The counts for today's Assembly. We have the Delegate and the Alternate, 6 Officers, 4 Committee Chairs, the DCMC and the Alternate, 9 DCMs, 4 Alternate DCMs, 31 GSRs, 2 Alternate GSRs, 5 Interested AAs and 2 Past Delegates. 68 people signed in. On the FNB website in New York, we are starting to get some of those numbers down. 14 Groups are listed as

incomplete, 145 is listed as unknown and 72 are listed with bad addresses. As of yesterday afternoon there were 739 listed active Groups in Area 53 and those are just the ones that New York are aware of. If you are unable to find a Service Number, your Group may not be listed with New York. Unknown Groups started at around 200 Groups at the beginning of the year. We are chipping away at that number and we couldn't do it without all of your help. If you have a change, email me at registrar@area53aa.org. I usually respond within a day or so. Recently we found that there was a miscommunication on how we are donating to Area 53. We are going to fix that. We had elections this past week for Secretary, Treasurer, GSR, Literature, Corrections and IGR. Had an Anniversary in September to discuss how we fund it, we collect a separate collection for our anniversary. This is separate from our 7th Tradition collection.

Dominique, GSR Creekside Recovery Group in Gahanna. We are a three day a week meeting. 4:30 to 5:30 pm on Tuesday, Wednesday and Thursday at the Gahanna Congregational Community Church. Rotating, Tuesday is Big Book, Wednesday is 12 and 12 and Thursday is discussion. We just celebrated our 2nd year anniversary and we consistently at 25 to 35 people. Most positions are filled. We do not have an IGR. It's a meeting with a lot of newcomers so they are not ready to jump into the service work, but they are open to it.
