AREA 53 PANEL 65 AREA ASSEMBLY MINUTES – MARCH 8, 2015, 1:00 P.M.

OPENING OF THE ASSEMBLY

- Peggy A., Area Chair, called the meeting to order with the "We" version of the Serenity Prayer
- Twelve Concepts (long form) was read by Kristi H., Delegate
- Roll Call: Note: Not everyone was back from lunch at time of Roll Call. GSR's and Alt's 31; DCM's and Alt's 5; Standing Committee Chairs 6; Area 53 Panel 65 Officers 5; Past Delegates 1.
- Review of the Agenda and December Assembly Minutes Motion made by Marcia H to accept the December Assembly Minutes, 2nd by Domineque. Motion passed.

BUSINESS MEETING – Peggy A. Area Chair

TREASURER'S REPORT – DAN S.

- 75 copies provided to assembly
- Previous balance \$8,087; Total Funds Available \$13,999
- All contributing groups posted on Treasurer Report. Dan stated the number of groups could be improved.
- Delegate expenses were paid
- Officer expenses were paid \$5,590
- Contribution for housing subsidy exhausted
- Committee expenses paid \$922
- Dan commented there were two ways to read the report. The first is that there is good stewardship and the second is that we are an active area by sending our Delegate to New York, and we have very active committees that are carrying the message.
- Questions; Steve S. GSR 3 Legacies Group the \$600 for the meeting and convention center expense? The \$600 covers contracting The Blue Moon Event Center in Grove City in June and September. \$300 was prepaid for rental of the facility.
- Kristi H. moves to accept the Treasurer's Report, Terry G. 2nd Motion carried.

UNFINISHED BUSINESS:

Area 53 Inventory Ad-hoc Committee Final Report 2014 – Greg M. A53, Panel 63 Chair

- Survey report was provided and made available in the April 2014 edition of the COGF's Conscious Contact Newsletter.
- There were only 31 Mail-in responses and 21 website responses received which equals 52 Total Surveys. About 29 groups responded (1 unknown Area) out of 720 (3.8%). Because of the low responses, this doesn't allow for a good sampling of possible group responses. This requires a visit to the Area website.
- Questions: Jackie asked which April Conscious Contact Newsletter- Answer- 2014. Becky M. asked how much money was spent on taking the inventory. Answer - \$430 was earmarked for the inventory but not all the funds were spent. The Inventory was not mailed out. Becky stated she would have preferred a written response.

Location of June Assembly – Peggy A. Area Chair

• Peggy stated that she and Steve S. had been working on finding a place and they came up with the Blue Moon Event Center 1604 Gateway Center in Grove City off I-79 South. Fliers are available. This place has a large meeting area. There is a microwave and refrigerator but no kitchen. There are bathrooms for both

sexes. Many restaurants are close by. The owner of the facility has coupons available for the restaurants. No deposit was needed. Each assembly is a \$300 flat fee. We can start at 8:00 a.m. and leave by 5:00 pm.

- Dan S., Treasurer, accommodated Peggy A. to the Blue Moon. They've already paid for June and September, and they will pay for December's event in June. Peggy stated her main goal was to find a place for all three assemblies.
- Questions: Steve S. asked if we could make our own coffee. Peggy stated pots were available. Jim F. asked how this relates to the Area Committee Meetings. Peggy stated they will still be held at the COGF.
- Peggy A. stated that all information for the Assembly will be on the website and she will email everyone as well. She also stated she would appreciate any feedback.

NEW BUSINESS

East Central Regional Request – Kristi H.

Kristi H. stated there are 5 states and 14 Delegates that participate in the East Central Region. Bill F. is our ECR Trustee. The region has allocated a Hospitality Room at the International Convention (in Georgia this year). Kristi makes a motion that we give them \$500 to provide supplies for the hospitality room. It was 2nd by Fred W. The floor was opened for discussion by Peggy A. Area Chair.

Sharon F. asked what they are going to do with the \$500. Kristi H. stated the main costs will be for supplies, handouts, coffee and water.

Brandy stated she received an email about the hospitality rooms and their goal was to raise \$7000. Water and coffee would be provided. She doesn't understand what all the money is to be used for. Kristi stated they're going to develop that budget more, but that there is a corking fee for the water too.

Madeline stated the email doesn't specifically state what they want the \$7000 for but that the \$500 from each Area is not required, they're just asking for it. She also stated that our hospitality room is not in a very visable area. What are some of the other areas doing? Kristi H. stated that she didn't receive the email with the \$7000 explanation. She also explained that she understood they were going to develop the budget more, but she did not hear that the hospitality room would not be well attended but that it should be well attended.

Jeanne S., Past Delegate A53 P59 stated that Kim R. Past Regional Trustee had seen the room and that it is in the main concourse with high traffic. The room should be well visited with expectations of 50,000 to attend. We should buy their product. Our next international will be in Detroit. It is not that expensive and there is no demand to contribute. We don't need to be that cheap. The International only comes around once every five years.

Rich B., Past Chairman, stated that they had served over 1100 people for a State Convention and the bill came to about \$11,000. We need to anticipate how many people would be there. In the past they have averaged over 60,000 people at the Internationals. What would be the impact to our budget? Dan S., Treasurer, stated taking out the \$500, it would leave us to \$114 above our prudent reserve.

Madeline stated from the email received from Fred C. that our suite is not a main corridor, casual traffic would come from hotel guests. She also stated that this is not a service event, it is a celebration. Advisory action in the past advises that no money should be used by GSO for a non-service event. Do we have the \$500 for a non-service function?

Sharon F. stated that she did not receive the memo. She also stated that our next International will be in our region in Detroit. We will want to publicize this. As a region, we voted to do this. We should support this.

Kristi H. stated that Dan S. gave the current bank balance. The end of the year balance will show that we do have money for this. Dan S. stated the way he arrived at that budget was when he looked at the 2014 budget it would come up to \$114 above the prudent reserve.

Stephanie S., DCM D16 asked if we would be charged for a schedule of volunteers? Kristi H. replied yes.

Dave C., Past Delegate, stated he did not know the \$500 fee was being discussed. He understands that all they're doing is asking to be self-supporting. We are part of the E. Central Region and we should be supporting this. This is a good way of carrying the message. He also stated the entrance is from the street and leads to hallway to the hospitality room.

Ryan C. DCM D17 called the question. Dan H. 2nd. Peggy A. stated we had to vote to call the question. 51 for, 1 opposed.

Kristi H. reinstated the motion to give the E. Central Region \$500 for the hospitality room at the International Convention. Sharon F. 2nd. 47 voted for, 14 opposed. Motion passed by 2/3 majority. No minority opinions. Motion passed.

OFFICER'S REPORTS - Dan H. Alternate Chair

- Alternate Chair Report Dan H., Alternate Chair, took over the 2nd half of the Assembly. He also stated he had nothing to report.
- **Delegate's Report** Kristi H. reported she's been two months into panel. She has attended conference of past and present delegates in Michigan and received background information. She stated there is a full agenda on the area website. She said will be attending other mini-conferences the next three weeks. Looking forward to going to New York.
- Area 53 Chairperson Peggy A. stated the new Area 53 Liaison is Terry G. She also stated that all DCM's should attend the Area Committee Meeting on April 12th at the COGF and will start at 10:30. Peggy also stated that all Area Officers and Chairs should attend at that time too. Jim F. asked if all interested AA's would be welcomed and Peggy replied yes, all can attend.
- Registrar Ed A. stated there were 92 members registered at this Assembly. The COGF office maintains updates from different groups. They keep up to date along with two other central offices, AOIO and Lancaster. An email from New York provides information for a regional directory that is published every year. They are asking for updates annually. Please pass on group information changes (locations, times, etc.). Send to Ed A. by May 8th or to New York. They don't say whether they are publishing one this year. If groups don't have current information, this will affect the mailing of your Box 459. To update, visit the Area 53 website and aa.org website. He also has forms available.

District and Group Reports

DCMC – Steve D. requested that all the DCM's attend the ACM on April 12th. Steve stated that there was
some confusion regarding how the DCM reports would be presented at the assembly. The agenda advised
that the DCM's would present the reports. The committee voted that the DCMC would highlight the DCM
reports. The purpose was to have an abbreviated meeting to cut down on some of the time of the
assembly. Two DCMs gave reports to Steve.

Stephanie S., DCM D16, stated she didn't recall that Steve was to read the reports. She was under the impression that the DCMs would read the GSRs reports.

Dana P., DCM D34, stated that the DCMs and GSRs would give the reports to Steve D. the night before for review so we could get through the process.

Ryan C., DCM D17, stated he received an email from Peggy A. Feb. 9th that DCMs would give the GSR reports. Ryan responded to Peggy's email, concerned that the reports should not be read by DCMs. The GSRs should give their own reports. He believes that the GSRs reading the reports validates the group's activities. It makes the district stronger. He said that in the interest of time is not a good reason to have someone else read the reports. He quoted Bill W. "The strength of our whole AA service structure starts with the group and the GSR the group elects. I cannot emphasize too strongly the GSR's importance... " Ryan stated he could never repay the debt for what AA has given him. That it is a valuable experience for the GSRs to give their own reports.
