Dan Highlights information regarding the December 2016 Budget

- Group Contributions at this time last year \$16,746 Contributions are up around 10%
- Groups making contributions are up from 184 to 200
- \$26,020 available and expenses include:
 - Officer Expenses
 - Delegate has gone to the General Service Conference
 - Alternate Delegate has gone to Mini-Conferences
 - Some officers have gone to neighboring Areas, Mini-Conferences and State Convention
 - Operating Expenses
 - Still uncertainty regarding status of Area 53 Archives
 - Line 16 shows deficit spending. New business will be a proposal to increase line item.
 - Reason for additional expense Purchase of Contribution Envelopes for \$300.
 - Other expenses include, IRS Reporting, Post Office Box, Projector Purchase, Website Services, Meeting and Convention Expenses, Support of the State Hospitality Room and State Convention and Committee Expenses.
 - Projected Balance \$9,491
 - Above Prudent Reserve of \$2,500

 Many expenses are front loaded in the First Quarter to include Mini-Conferences and General Service Conference.

Unfinished Business

Area Inventory - Dan S.

Area 53 is embedding Inventory Action into all of our gatherings.

- The General Service Office has started to incorporate Inventory at the General Service Conference which is documented in the conference report.
- Taking inventory in the best sense of the word is a fundamental aspect of AA's program of recovery. As program co-founder, Bill W. reflected in AA Comes of Age on page 231. "Just as each A.A. must continue to take his moral inventory and act upon it, so must our whole society if we are to survive and if we are to serve usefully and well." A.A. General Service Conference Inventory, 2015 (page 3).
- The 10th Step talks about a continuous inventory which means without cessation.
- It gives us the opportunity to find out were are the gaps and were we need to fill the gaps. All towards the end of serving the alcoholic usefully and well.

At the 2015 Mini-Conference there was a Committee for Inventory. They referenced the Guidelines and came up with three areas to examine, we added one to allow for one topic for each Assembly.

- 1) The Mini-Conference Committee
- 2) The Area 53 Committee
- 3) The Area 53 Assembly
- **4) Membership and Financial Support** (was added)

The intent is to look at these questions and offer input. Then the Area Committee which will meet the month after the Assembly can act upon what we find today. At the Next Assembly, we will report what actions we took. We are continually taking a look at ourselves to see how we can better serve the suffering alcoholic and how to better do what is pointed out to us in our Guidelines. The topics are arranged chronologically.

How Area 53 Discusses the Inventory

At the Area Committee Meeting

The Inventory Question will be distributed hard-copy and will be published on-line.

At the Area 53 Assembly

- We invite people that have reviewed the questions to come to the Mic
- The Recording Secretary make available all the information prior to the next Area Committee Meeting.
- The Area Committee will review the results.

Considerations and Recommendations from the Area 53 Planning Committee (October 2016)

- We talk a lot in acronyms. One of our members, Kathy, brought that to the attention of the Area Planning Committee. As a result, a legend was created on our Agenda to show what those acronyms mean.
- Area 53 has a continuous challenge in how we communicate the process on things like election procedures and the development of an Agenda. Area has a commitment to continue to work towards fostering communication between all involved parties.
- Dan said that he is encouraged by the Inventory Process because of changes that are taking place.

The questions below were considered at the December 2016 Assembly.

Reflecting on the Area 53 Guidelines (Articles II & XII), is our Area attracting alcoholics from different backgrounds to available service opportunities? Are we seeing a good cross-section of our community, including those with special needs? Do our practices honor our heritage of inclusion and achieve diversity within our A.A. Community?

From the Area 53 Guidelines: Article II – above

From the Area 53 Guidelines: Article XII

- 1. At the September Area 53 Assembly Meeting of each even-numbered year, the Area Assembly will hold elections of the Area Delegate, Alternate Delegate, Chairperson, Alternate Chairperson, Registrar, Alternate Registrar, Secretary, Alternate Secretary, Treasurer, and Alternate Treasurer.
- 2. The term of service for these individuals will be for two years and will begin January 1 of the following year.
- 3. At the beginning of this even-numbered election year, the Chairperson will ask the immediate Past Delegate to chair an ad hoc nomination committee to identify, secure, and submit names of qualified nominees.

Do our trusted servants stick with us, or does the turnover seem excessive? If so, why? What can we as an Area do to retain our trusted servants?

How is our Area fulfilling its responsibility to the Seventh Tradition?

Comments from the Area 53 floor.

Dan S, Area 53 Treasurer –

• Dan reads the questions regarding diversity and asks how do we measure that. Alcoholics Anonymous General Service does a survey of our membership every 3 years. Dan recommends that we use GSOs findings as a way of how we are represented in our Area relative to the Alcoholics Anonymous community. Dan then reads the remaining questions on turnover and Seventh Tradition. He then opens the floor for comments.

Mike M, DCMC, Area 53, Panel 67 –

• One of the things that I have seen in the Area, in the Committee work and in the Districts, is that we have this kind of two year mentality. We go through our position and there is almost a kind of relief and a rush to get done with it. We just pass it on the the next people. Often times it feels like we are reinventing the wheel each time. I know in the Special Needs Committee, I already served my two years and probably stayed on for close to another year, maybe. I felt some obligation to insure that they were successful. Plus they were enthusiastic and a great bunch. Next year when our new DCM came in, I told her and the District that I would keep coming to the District meetings because I want to help that transition. I feel that we don't do as good of a job as we could on transition. I feel we could do better just by maybe staying a little beyond our position to help insure that the next people that are coming in benefit from the wisdom and experience that we already have achieved. Let's not get to the two year point and drop off and let it go.

Kalen C, DCM, District 30 –

• In terms of the turnover – seems like it was okay. People were staying around, at least in some sort of service position. As far as responsibility of the Seventh Tradition, there are still quite a few Groups that are very insular – all the people that came into that Group, stay there and do what they do. It would be better to have a broader sense of what AA does.

Cheryl S, CPC/PI -

I want to say that this inventory has been invaluable to me to look at how we are doing the job that we are assigned to do or step up to do and how we can better work together. I am really appreciative of the way that's being done. The first section of it – Is our Area attracting alcoholics from different backgrounds across sections, including those with special needs. I am not exactly sure how we can do that. I think that the brainstorming and the bringing it up would be helpful. I know that we look at things like handicap accessible... We're looking at were we are going to meet as an Assembly and diversity – inclusion and diversity – I've had challenges with the Committee with this past Panel in that the Committee meetings are here in Columbus and people have to travel a long way. How do I communicate with the Committee. The website has been absolutely fantastic as far as getting the minutes to there. Yet, there are some people that don't have access to that. A new perspective is what I'm thinking of. Perhaps, mailing out Minutes and things like that. So, the last question, as far as the Area fulfilling it responsibility. From the Treasurer's Report, it shows that we are improving and that is what Service is about. It's about improving. We need to continually look at ourselves. I thank the Committee and all of the people that worked on getting this inventory together and then reporting back. Thank you.

Frank G, Alternate Delegate –

• With minimal success, I encouraged District Committee Members to approach individuals, if they had a little time, to encourage people that they can be a GSR. A lot of them are surprised that they are eligible. You're sober right, you work your steps right, you're eligible. Unfortunately, quite often, they come to one Assembly or one DCM Meeting and it just doesn't seem to be their cup of tea. All I can do with my views is to keep bringing this up to the individuals and every once in a while they stick. Thank you.

Teri G, Inter-group Liaison –

• I have to agree with Mike. I see a lot of people that involved in service work – It started when I was Group Secretary. At the end of two years is a long time to have a commitment. Especially when you have a large Group. It's like, "Whew – It's over." Being of Service doesn't mean at the end of those two years that it's over. I think one of the things that we do in our District, those of us that have served, do stay active. Whether it just be attending the meetings still. We have a brand new DCM that is new to being a GSR and DCM. We have three new GSRs that are here today that I am excited to see. So those of us that do stick around, they can just keep setting the example and trying to get new fresh faces in here and they will share that with their peers as well – and getting some more Groups involved. It's nice to see that the inventory we did, back with our homegroups is being evaluated so that we can see that being a GSR is important. Because we are discussing what our Groups are talking about. As far as the special needs, I think that being on the Special Needs Committee and that is an area that I am staying on – this is my third or fourth year. I think we think of the physically handicapped is the only thing the requires a special need. Being on that Committee we like to think that there is more than just that. Thanks.

Peggy A, Area 53 Chairperson –

• I would like to make a comment of the part where it says, "What improvement could be considered to make sure Agenda items and Conference Activities have a broader appeal and attract more members to attend." My suggestion would be that during my time as a Chairperson, I have heard many things about how long the Assembly is and how big the Agenda is. I would suggest that maybe we could get a Committee together for people that are concerned about that and to come up with suggestions to make it different. I mean, you know there certain Guidelines and things that have to be on the Agenda. The time when we are doing the open mic, the Chairperson has nothing to do with how long long those open mic sessions take. So if anyone has any suggestions or any feedback they might want to get with the new Chairperson, Dan H and assist him with that. Thank you.

Dan S reminds the Area that we are talking about the December Inventory questions.

Greg, DCM, District 22 –

• In terms of transition of leadership, I have been involved in some organizations that have a President Elect, the President and the Past President. That gets a lot of bureaucracy there, but it does kind of provide a transition. Would that look like six years then, two years pre, then two ... maybe cut it down to one year. One year pre, one year active, one year later – I don't know. That may be a possibility. On the Election, it was my first election, at the last Assembly, it seemed like there was a lot of concern, over the process and confusion over it. And the repetition of the voting and I have kind of reflected on it and talked to some people and kind of

see the purpose. Maybe if that was explained at the beginning of the voting process, that may be helpful. Thanks.

Sharon F, Past Delegate –

The first part about diversity, we're not a diverse group here. Look around, we're not a diverse group. I thinks that's a common problem in Alcoholics Anonymous. Especially in Service. We're just not. It's not just here. It's not just Area 53. There are a lot of Areas that are not diverse. I think that Area 54 in Ohio does a good job of that. I am not sure exactly sure how they do it. But, they have a pretty diverse group. I don't know how you address that part about people staying in office. I remember when I was Chairperson it was such a big deal to be elected and then the work started. The ego is really strong when you got elected and then the work started. I am not sure how that we can encourage people to stick around. That would be a great thing. The other thing about the contributions and I am glad that you brought up that more Groups have contributed this time. That's great. What's our percentage for the General Service Office? 23 percent of the Groups give to GSO. We have always tried to address this. It's something that we try to address on a continuing basis. You can talk to your Groups and your District about contributions, I think that helps. Our District, District 15 we have a pretty good percentage of groups that contribute, compared to other Districts – not everybody in District 15 contributes. Those are things that we have to continually talk about to Groups and Districts, members. It's just a continuing thing. I really to believe that some Groups don't know that they are supposed to contribute and I also believe that some groups don't have the money to give. But even if they gave two dollars – I always say this. If you gave two dollars to GSO you would be considered in that percentage. Think about that, you don't have to give a lot of money. Thanks.

Dave C, Past Delegate –

• On this one question, what can we do as an Area to retain our trusted servants. The first thing I think of is, the most important servant is the GSR. I know of a lot of organizations, when they have turnover or at the end of the season – baseball teams, pro teams, they conduct interviews at the end of the season and talk about what they learned and how the person is doing. Can we apply that in anyway to outgoing GSRs. Because is seems that it might be the key point of continuing to attract GSRs to further their service experience. Whether it would be Committee work or any other type of General Service opportunity. Maybe we can learn something from what those GSRs felt they kept getting confused about or getting mixed signals in not getting thing explained well enough to them. If there is some way of gathering GSRs that are going out, transitioning out or moving on, If the Area could get a few of them together to figure out what they learned and what they didn't learn. You would have to figure out what a good list of questions would be. This is just a suggestion.

Donna K, Treasurer. Area 53, Panel 67 –

• If we had more DCMs that are covering our whole Area, they would be going out and talking to these groups and getting more GSRs. We would have a more diverse room here. We would have people that are more active and stay active. Because if a DCM has enthusiasm, that I have seen in some DCMs, they get out to those Groups and they talk to them. There are a lot of Groups out there that don't even know what a GSR is. In our meeting we study Concepts. You know how many people come to our meeting and say, what in the world is that? They have

never ever heard of that. They have been sober for a long time sometimes. I think it is our job to get more DCMs active, to get out to the Groups and if you look at our Treasurer's report, we only have a couple of Groups or Committees that are active. The more GSRs you got the more people that you are going to learn about these Committees. The Committees are there to help the still suffering alcoholic. If you don't have activity on those Committees, that are getting out to the community in general. You've got CPC/PI.... No one is doing Treatment Facilities. There are all of these treatment facilities that are popping up, that I have never even heard of because of this epidemic that is going on with heroin and they think that is the only problem. They don't even look at alcoholism anymore. It seems like it anyway. I really believe that if we get more DCMs out there, our Area would take more time to get out to these Groups and let them know, we need to get your District active and start electing a DCM and tell them what that is about. A lot of these Districts in our Area don't know what that is about. I have been around for years, it always seem like it the same Districts that are here. If you might come out of the dark, every couple of years, then when that person rotates out and sometimes those people don't stick around and it goes dark again. I think that is the gist of what we need to do, as an Area we need to get out to the Groups. We got to get out to the Groups and tell them what a DCM and what is a GSR. Don't expect them to come to us.

Stephen S. Alternate GSR, After Work Group –

• On the aspect of diversity... My experience in other parts of the country is that the Areas that do a good job with Hispanic participation are ones that create all Area or all county Districts, rather than geographically limited. So right now if you want to get an Hispanic group involved.... District 34 has made a great effort to get the Hispanic meetings there involve with District, but they're just one in a very small minority position in term of bringing their cultural issue to the table. But when you get a Hispanic District for all of Columbus, or all of Franklin County, with a DCM, then you get representation of their viewpoint on an equal basis with them. So I know Cleveland doesn't have a District like that, but they have an Area Liaison. Chicago has got about three or four. Los Angeles has about five that I know of. I have been to a couple of the LA Assemblies, because I am from out there, and they are really leaders in the Area in terms of bringing principles to the table. I think we ought to be concerned about how we structure Districts and think about how we can get one that actually creates some additional equal participative opportunities for the minorities.

Dan S encourages people to look at the 2014 Membership Survey to compare Area 53 with AA as a whole in regards to diversity.

Steve D, DCMC -

• I think it comes down to what my enthusiasm when it comes to retaining trusted servants. If I leave an Assembly and go back to my Group and complain about what happened at this Assembly, like it's a drudgery to come here, I am not going to make anybody enthusiastic about coming here. When I stepped up to take a position, in Alcoholics Anonymous, I stepped up to take a position of responsibility. I don't care how long it takes, while I am here, I am sure that there is a lot of privileged stuff that goes on, but still it is about my enthusiasm. Am I committed to my District and am I committed to my job as trusted servant. And do I pass that on to the people that I sponsor? And do I sound enthused when I am talking about Alcoholics Anonymous and the service structure? I have heard of old timers that have been around for

years, longer than I have, and "don't wanna get caught in politics" but they don't understand the Concepts and the Traditions. They think that there is politics in this stuff. I have to remember, am I doing my personal opinion or am I doing what's best for Alcoholics Anonymous when I come in here. I have to express what we did to improve or to help out Alcoholics Anonymous and whats best and keep my personal things out of it. That is what I have to remember, whether I am in an Alcoholics Anonymous meeting or Service meeting or Committee meeting. What is best for Alcoholics Anonymous. Thank you.

Madeline H, Past Delegate –

I really like what Steve said. I know we all complain, we all do, we just gotta be careful who we complain to. If it is a brand new person, that knows nothing about about what we are talking about, maybe that wouldn't be the ideal person to complain to. Our sponsors might be, or someone else that is involved in the Area. Because we are going to do it. I'm telling you, we are alcoholics – so we're gonna do it. But we have to be careful as to were we are going to do that kind of thing at. I want to talk on diversity, because I sat there and kept thinking and looking around the room and I thought when I was coming up in service in 1991, there was hardly any women in the room and there was hardly any young people in the room. I was considered like the odd-ball in the room. So I do think we have some diversity in Alcoholics Anonymous. It may not be by the color of our skin, but that question in the inventory goes deeper than just that. It's economic, It's social, It's a lot of things, not just the color of our skin. So I think we have a lot of diversity. I know when I went to conference, out of 93 Delegates there were 11 women. I bet there are a whole lot more than that. I bet Kristi can attest to. At least half. Do you know how hard that was? – for the women to break into that arena. It was not easy. AA has been known for the old white guy. People will say that. I think we need to quit saying that. It's not true anymore. We can keep saying it, but it's not true. I see a diverse age group in here today. So I am sort of encourage by the fact that Alcoholics Anonymous in their general service has become much more open minded to the ideas of our whole fellowship and not just a few old white guys.

Dan thanks Madeline and makes reference to the 2014 Membership Survey. He says that another aspect of diversity is length of sobriety. They look at occupations, how you were introduced to AA, age, marital status, do you have a homegroup, how many meetings a week you attend, and ethnic and racial background.

Dan says that we will get the minutes disseminated at the next Area Planning Committee and will discuss it and see how we can improve. Area will talk about it, act on it and come back to you during the March Assembly.

Ad-Hoc Committee Report Digital Communications – Stephen S.

The report for the Ad-Hoc Committee on Digital Communication is available at http://area53aa.org/main/wp-content/uploads/2016/06/Ad-hoc-Web-Committee-Report.pdf

Stephen explains that the was asked to give the report in place of Dan H. and also to chair the discussion and action on the Guideline change.

Background

- June was a Guideline change proposal to create an website administrator position.
 - Failed to get substantial unanimity and didn't pass.
 - Recommendations was made and passed by the Assembly to have the Area Chairperson appoint an ad-hoc committee to look at the issue.
 - Dan H was asked to chair the committee of six people.
- Ad-hoc Committee met between June and September.
- They defined how Area 53 is to approach the subject of Digital Communications and advised on possible solution.
 - The first website was developed in 2005.
 - In 2007 the website became part of the registrar's job to administer.
 - In 2009. There was a Guideline change to place the website under Public Information in conformity with GSO Standards. Then the websites purpose was to communicate with the general public. The webmaster was to be accountable to the Assembly as a whole.
- The website has become an important part in the way Area 53 functions. It was a mechanism by which a lot of information is exchanged.
- There has been a tremendous change in the way websites are used and the way digital communication takes place and the website is no longer a public information function.
- The conclusion is that we cannot leave the Guidelines as they are because it isn't consistent with what we are doing and with what GSO is doing.
 - Advised by Bill F. that GSO has placed the website under the Communications Desk and is considered independent.
- The website has become a part of what Area 53 does and the Fourth Concept, The Right of Participation, argues that the Digital Communications ought to have a voting role.
- The Committee thought that the Principle of Rotation should be brought into decision making process.
- The committee considered the pros and cons of the following options:
 - A. No Change
 - B. Elected Officer presented in June 2016
 - C. Appointed Person(s) by Chairperson
 - D. Standing Committee
 - E. Paid Individual
 - F. Ad-hoc or Special Committee
- At the September Assembly the Ad-hoc Committee presented a progress report. The Assembly requests that the Ad-hoc Committee present to the Area Planning Committee so that they could decide what actions to take.
- In October the Ad-hoc Committee presentation was made to the Area Planning Committee
 - The Ad-hoc Committee didn't make a specific recommendation but eliminated four options and left two. --- Elected Officer and Special Committee.
 - The problem with an *Appointed Person*
 - They felt that this would cause hardship in creating a Guideline change.
 - There would be no specific detail on how to specify Spirit of Rotation
 - The individual would report to Chair only.

- The Assembly wouldn't have any say as to who would be assigned to the position except to say that they oppose the appointment.
- The problem with creating a *Standing Committees*
 - According to the Guidelines, the Chairperson of the Standing Committee is elected by the Standing Committee. The only time that the Area will elect a chairperson is if the Committee isn't active or if the Committee can't find someone to chair.
 - The Ad-hoc Committee felt that the Standing Committee approach is inconsistent with the idea of answering the Assembly as a whole.
- The problem with *Paid Individual*.
 - Money
 - Legal Situations
 - Possible impact on IRS Standing
 - Too Complicated, too expensive.
- The Special Committee approach would allow the Assembly to elect a chair.
- The final vote of the Ad-hoc Committee:
 - 3 for option B, Elected Officer
 - 2 votes for option F, Special Committee
 - 1 vote for option A, No Change
- With this information, the Area Planning Committee gives a presentation Assembly for consideration.
 - The Area Planning Committee doesn't make decisions
 - The Area Planning Committee makes a decision on what the Assembly should consider

The Area Planning Committee recommends an Elected Officer

- The Area Assembly, as a whole to be able to make a choice as to the officers
- The Spirit of Rotation will be built into the process which is an added advantage over the Special Committee.
- The Area Planning Committee cleaned up the previous presentation regarding the Elected Officer and created a new simplified Guideline Change.
 - This is not the same Guideline change that was rejected in June.
- Stephen describes the three step process in establishing a Guideline Change
 - The person wanting the change brings the recommendation to the Area 53 Chair to present it to the Area Committee. The Area Planning Committee reviews the recommendation and makes it presentable to the next Assembly.
 - The recommendation then went to the Assembly for Consideration. The Assembly decides whether there is enough merit to consider the recommendation.
 - The actual vote on the first recommendation took place in June. The vote didn't make substantial unanimity so the recommendation failed.
 - After the failure of the proposal it went back to the Area Planning Committee.
 - The Area Planning Committee is requesting that Assembly consider that the modified version of this recommendation has already been through the process of consideration and to have the final vote at the March Assembly is unnecessary. The Area Planning

Committee is advising that the spirit of the Guideline is accomplished and that we go to the vote on the actual merits of the recommendation which would require substantial unanimity.

- Stephen requests a vote from the Assembly to decide whether the Assembly should have a "Vote to Consider" then in March actually vote on the recommendation.
- Madeline makes a point of clarification. She advises that an Ad-hoc Committee
 doesn't create Agenda Items they just give information only. To request that that
 Assembly vote on a determination on how to proceed is very odd. A motion is now
 needed from the Assembly.
- Kristi makes a motion to vote on the Guideline change today. Cat R. seconds
- "That the Area 53 Guidelines be amended:

Remove Item 2e from Article IX-Standing Committee Areas of Activity, Add Web Administrator to Article V-Area Assembly Officers with the addendum that we vote on the item today."

- Stephen opens the floor for discussion and attempts to clarify that the vote is only to consider having the final vote on the recommendation at this Assembly.
- Jean S. Past Delegate advises that any Guideline change recommendation has to be mailed out to every voting member of the Area to be taken to the Groups to get feedback within 15 days of it's presentation, which is today. If we vote on implementing today are we not violating our own Guidelines.
- Stephen advises that the Area Committee has said that the consideration stage has already been accomplished.
- Jean S. disagrees. A final recommendation hasn't been mailed out to the Groups to get feedback.
- Stephen said that in order to stay consistent with the understanding of the Guidelines a Motion to Table until March is needed.
- A Motion to Table was presented by Molly, Second by Jen
 - No discussion, Majority to pass,

Proposed Budget for 2017 – Dan S, Area 53 Treasurer

Dan distributes the Proposed budget for 2017 and said that the Area Planning Committee has reviewed the proposal. Dan then advises that the has made a proposal that is different in three ways.

- Line item 10 (Past Delegates to CDPP/Area53 Mini-Conference was originally \$1000 was increased by \$200.
- Line item 1 and 2. Increased beginning bank balance to \$9,600.
 - Dan believes that due to increased participation from the Groups.

Discussion

Paul H. - Has a question on Delegate expenses/Chairperson expenses. We are budgeting \$3000 and \$1000 respectively. This year we already exceeded those numbers. Why aren't they higher?

- Dan S The Chairperson expense was originally adjusted at \$1,200 and was increased to \$1,700 at the Mini-Conference in March because the Chairperson had additional travel. The Assembly approved the increase. The number reflects that this may not be the case with the new Chairperson. The Delegate increase was due to Kristi living further away, went to Conference of Delegate's Past and Present and the Regional Conference. The new Delegate may not have the same expenses in 2017.
- Dan has some discussion with the Delegate and advises that line item 6 should remain at \$3000 and if needed it can be adjusted at the Assembly.

Fred , Newly Elected Social Chair for COGF – I don't see a Unity Day. It doesn't look like it has been held for the last two years. In our By Laws, it's part of the duties of the Social Chair. Has that been taken out out of the budget?

- Dan S. It's been taken out of the budget. Not because the Area doesn't want to do it. Because there hasn't been any participation.
