Report from Intergroup Liaison Committee

The Area 53 Intergroup Liaison Committee had its quarterly meeting February 2nd with COGF (Central Ohio Group Fellowship), LAI (Lancaster Area Intergroup) and AOIO (Appalachian Ohio Intergroup Office) attending.

- Patty, Officer Manager at COGF, said last week that they will hold the prices of AA conference approved books down as long as possible by buying as much inventory now. They were able to keep prices down almost 10 months after the last increase in 2014.
- COGF is now using STRIPE an online payment service for in-store sales, and groups and individuals will hopefully find it easier to make contributions. LAI is interested in exploring and AOIO may be too.
- COGF's Spring Meeting Books are now available.
- VOLUNTEERS are always wanted. COGF is looking for 12-Step volunteers to return calls from still-suffering alcoholics, which can be after 5 pm and sometimes during the night.

COGF, LAI, and AOIO all have officers on their Advisory Board or Steering Committees.

- COGF is open M-F 9-5 and Sat 9-1 and staffed by its office manager, assistant managers, and volunteers.
- LAI is open M-S 10-2 and staffed by its office manager and volunteers.
- AOIO is open during daily noon meetings when an Advisory Board member is present.
