## **REGISTRAR'S REPORT TO AREA 53 ASSEMBLY**

**JUNE 4, 2023**

### **GSO Stops Sending Print Docs via Postal Mail**

I feel responsible to raise the awareness in this assembly that our General Service Office has implemented a major policy decision to cease sending print documents via postal mail in favor of electronic documents via email. They have made this change without consulting the General Service Conference. In fact, I cannot register a GSR on the Fellowship Connection database who does not have an email. I have to wonder if this best serves the needs of the fellowship. Can GSRs and DCMs effectively share information when many do not have the resources to print the documents and take them to their groups or business meetings?

I wonder if the time has come for Area 53 to submit a Proposed Agenda Item for the 74<sup>th</sup> General Service Conference that would give trusted servants an opportunity to choose whether they prefer correspondence in print via the mail?

### **GSR Kits**

Several trusted servants have been frustrated that they have not yet received print GSR kits in the mail. , Many members prefer to have printed documents.

### **Group Information Updates**

Throughout this panel I have been working with DCMs and GSRs to update group information. I have been very gratified by the willingness of several DCMs in several districts to update information. One of the most significant observations has been that the number of groups is declining by about 30% in districts where a thorough effort to bring the list up to date has been made.

June 4, 2023

Our committee has been busy establishing roles for members and reaching out to health organizations to staff booths within the Columbus area and surrounding cities. We've created new business cards, in addition to the ones used by previous committees, that focus on our function as an Area service - the QR code links them to the Area website.

We recently spearheaded an effort to get more Big Books in the Columbus Metropolitan Library, asking the AA groups to this donation opportunity. This not only put 23 brand new copies of our basic text into a notable public institution but further more it showed that there are many ways the groups can carry the message to the prospective alcoholic. With the surplus of Big Books we received, I reached out to the DCMs to see if there are libraries within their district that would accept a donation.

Lastly, we've been working on our relationship with Central Ohio Greater Fellowship (COGF), in hopes of coordinating our outreach and ensuring that event requests are staffed. We've invited the PI Chair of Central Office to attend our committee meetings and included her in conversations of any noteworthy activity. We hope to soon assign one of our committee members to attend their Advisory Board meetings regularly.

Our expenses to date have amounted to \$224.05, leaving us with a balance of \$925.70.

## **Sunday, June 4, 2023 Area 53 Grapevine Quarterly Report**

At that time we will review our past year and possibly request more funds to continuing attending events to promote the Grapevine.

Last but not least, The GVC is collecting old Grapevines so we can redistribute them at other meetings or donate to certain places. If your HG does not have Grapevines to set out for free please, let me know and I will get some for you.

This new service entity is registered with G.S.O. as an Intergroup for online-only Area 53 groups that are registered with G.S.O. This is the first online Intergroup within the United States-Canada General Service Structure to be registered and recognized by G.S.O.

Initially, the new Intergroup will provide only one service, a meeting list of online-only registered A.A. Groups that is connected to the Meeting Guide App. This assures that all meetings of A.A. Groups that are recognized by G.S.O. as Area 53 Groups will be available in The Meeting Guide App, the now universally recognized best source of A.A. meeting information.

Membership in COOLAA Intergroup will not be available to all online meetings, only those groups that are registered with G.S.O. as Virtual Area 53 Groups. The act of registering serves as a group's declaration that it is a local, not an international, A.A. online group. This distinction between Area-based and International online groups was created by an Advisory Action of the 71st General Service Conference to "recognize online groups and encourage their participation, listing those groups who ask to be listed within the group's preferred district and area... which supersedes the 1997 Advisory Action that designated online groups as 'International Correspondence Meetings.'"

The COOLAA Intergroup meeting list will necessarily be small in number, more like a District than an Area website. There are currently about thirty groups that potentially qualify for membership. COOLAA Intergroup will not include hybrid groups because these are already listed in the Meeting Guide App through the other four Area 53 Intergroups.

The initial action of the new Intergroup will be to reach out to the qualified groups to encourage them to register with G.S.O. and join COOLAA so their meeting(s) can be included in the Meeting Guide App. The planned actions are those associated with lighting up a dark district.
