Changing the date to September 15th will give the Finance Committee ample time to meet as many times as necessary, to discuss, make changes and prepare a budget to be presented to the Area Committee at the October meeting (**2nd Sunday in October**).

DECEMBER 10, 2023

Groups in Area 53 – Currently there are 861 registered groups in Area 53. These include 693 Active groups with a contact. 687 are Regular Meetings and 6 are Virtual. There are 168 Unknown groups with no contact.

168 Unknown Groups – General Service Office is requesting a more vigorous effort throughout the fellowship to investigate the status of Unknown Groups. These are groups for which there is no GSR or Mail Contact. Some of these 168 groups have probably closed. I need help from the DCMs in determining which groups in their districts have closed?

Proposed Agenda Item – At the September 10th Area 53 Assembly we voted to submit a Conference Agenda Item for the 74th General Service Conference concerning mail format. I was asked by the Chairperson, Marcia H to write the submission form. After completion, the PAI Submission Form was shared with the Chair, Delegate, and several Past Delegates and Past Trustees, requesting feedback prior to submission. My thanks to those who replied and to Delegate, Ed A for his role in submitting the official document on behalf of Area 53. Later in today's meeting I will provide a status report on that topic.

East Central Regional Forum – I attended the ECR Forum over the weekend, November 17-19, 2023. I have no documents to share because none were provided in hard copy. There was a QR Code provided and the Trustees indicate that these will be provided with the Forum Report which is to be emailed to all participants. 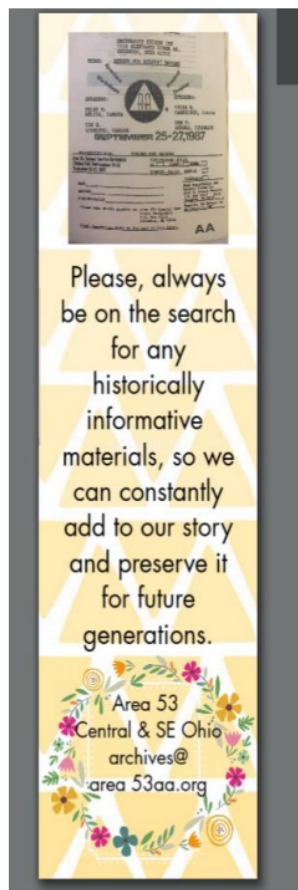
Area 53 Archives Committee Quarterly Report

Central Ohio Group Fellowship

COGF will continue to have Hard Back Books on sale at \$9.75 and the 75th Anniversary First Edition Big Books for \$5. Other AA World Services literature that we can get before January 15 will stay at the prices that they have been prior to the recent price increase by AAWS. They have a literature sale going on until January 15, 2024 that we are trying to take advantage of.

We have been able to acquire several hundred pocket Big Books for Area 53 Treatment Facility Committee at a reduced price and have saved Area 53 CFC Committee a very good chunk of change in the past several months by purchasing as much softback literature that they typically buy to take into facilities as we could. We look forward to continuing to work with all committees to serve any still suffering alcoholic that we can.

COGF has registered our first Russian speaking meeting in our area. It is Wednesday night at 7pm at King Ave. UMC 299 King Ave. Columbus, OH 43201.

We are excited to share that at our upcoming elections on December 8 at 10am at 645 W Broad St. many of our existing Advisory Board Members are planning to stand for other positions to give us some continuity on the Board which is greatly needed and appreciated.

Licking County Intergroup Office

LICO's office manager, Ben H., attends the weekly Zoom Office Managers meeting of Intergroup/Central Offices of AA. Currently 39 meetings. For the IGR Orientation Meeting in September and the Quarterly IGR Meeting in October, he visited meetings in Licking County to share about selecting an intergroup representative, volunteering in the office, and making regular contributions to fund the office.
