# REGISTRAR'S REPORT TO AREA 53 ASSEMBLY MARCH 10, 2024

**Groups in Area 53** – Currently there are 852 registered groups in Area 53. These include 688 Active groups with a contact. 682 are Regular Meetings and 6 are Virtual. There are 163 Unknown groups with no contact.

163 Unknown Groups – General Service Office is requesting a more vigorous effort throughout the fellowship to investigate the status of Unknown Groups. These are groups for which there is no GSR or Mail Contact. Some of these 163 groups have probably closed. Thank you to Paul T, DCM for District 34. Thanks to his efforts, we have reduced the number by 5. Thanks to the District Committees for District 33 and 37 for the effort you are currently giving as well. However, there is still much more to do as we try to improve the integrity of our data.

**Group Information Updates** – I have been receiving several group information / GSR updates and DCM updates in this first quarter. These have all been entered to the database. Any new GSRs or DCMs or any other group information changes, please send them to me either by email or phone.

**Proposed Agenda Item** – At the September 10th Area 53 Assembly we voted to submit a Conference Agenda Item for the 74<sup>th</sup> General Service Conference concerning mail format. I was asked by the Chairperson, Marcia H to serve as the Area 53 contact concerning this topic. The Conference Coordinator declined the submission. Furthermore, we have recently received a reply from the AAWS Board in which they inform us that they would not be allowing choice of mail format. While this was disappointing, we are heartened by the mention in the AAWS Board Highlights that they are discussing a survey regarding the question of need to make **Box 459** available in print. I have sent an email to the AAWS Board Chair asking who will be receiving the survey, by what mean and when it will be distributed?

I am pleased to announce that Area 53 Archives Committee did contribute to the 26<sup>th</sup> National Archives Workshop. The "archives bookmarks," that Teri G. and the committee designed and printed were well received and were gobbled up quickly. I introduced the Pamphlet "History of AA in Central Ohio" produced by Mark C. and COGF. Linda P. Archivist of Area 84 and one of the presenters, appreciated the piece. She has a copy and will use it as an example of preserving or AA History in her presentation.

One of the sessions, was a recording of Bill W. speaking. What really hit me hard, Bill said "Ebby could not stay sober because he could not get the concept of giving." (Without demanding in return)

The archivist room was a splendid display of artifacts from all over America and Canada. An endless supply of books, letters, pictures, and trinkets. All having a value of preserving our AA History. In the back of the room were many wooden framed 3'X 4' pictures of the many early members that had an influence on AA. One Picture especially caught my eye, Henry P. (Hank) was essential in getting the Big Book Published, he was a very sharp looking man and brilliant in getting business matters accomplished. I was saddened to read his bio, after four years of sobriety he went on a terrific bender and drank until his death. I pray that I NEVER FORGET, I will always be an alcoholic and the understanding "We work our solution on the spiritual as well as an altruistic plane."

Alcoholics Anonymous, Area 53 and District 12 has allowed me to be of service all over Ohio, several different states and now Canada. Because of these experiences, I got an education in the human and Alcoholic condition. These opportunities have given me a great appreciation and respect for our thirty-six principles and to be effective in passing on AA message.



### Proposed Guideline Change Presented to Area 53 - December 10, 2023

Proposed Change to Article VIII, Section 2) e) (Reference: See page 5 of the Area 53 Guidelines)

### **Current Wording:**

- e) Should a Standing Committee require support from the Area, the Chair of the committee shall submit a budget request to the Area Treasurer by October 1st for consideration for inclusion in the yearly budget prepared by the Finance Committee.

### **Proposed Wording:**

- 2) Chairpersons of Committees
- e) Should a Standing Committee require support from the Area, the Chair of the committee shall submit a budget request to the Area Treasurer by **September**15<sup>th</sup> for consideration for inclusion in the yearly budget prepared by the Finance Committee.

### Rationale:

Changing the date to September 15<sup>th</sup> will give the Finance Committee ample time to meet as many times as necessary, to discuss, make changes and prepare a budget to be presented to the Area Committee at the October meeting (2<sup>nd</sup> Sunday in October).
